Follow safety guidelines for handling instruments see HTM 01-05. To operate dosing bottle, remove the cap from the measuring chamber, squeeze the bottle gently until the required volume is dispensed into the chamber. Carefully pour the dispensed product into the correct volume of water for the cleaning application. Please refer to product safety data sheet before use. Use only as directed
